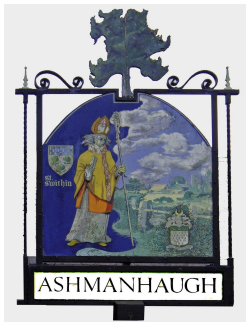

A number of planning applications were dealt with and work to improve the Common continued.

5 Church Warden report - Anne Mulhall

In this last year 28 services have been held at St. Swithin's including special celebrations at Christmas, Candlemas, Easter, Harvest and Remembrance Sunday. Since last year we have welcomed Rector David and Angela Smith, and we look forward to working with them for many years to come.

Thanks to go out to many who have supported the church over the year. During the inter-regnum Rob Hume, Barbara McGoun, Pauline Simpson and several retired clergy did a fantastic job so we were able to have the normal number of services. As ever organ players are in short supply and the purchase of a hymnal for use across the benefice has been very useful. However, there is nothing like the real thing and so many thanks go to Hazel Flavell and Richard Greenslade who have stepped in for key events. Another thank you must go to Harry Buxton who has remained as fabric officer for us despite stepping down from the PCC. Liam Mulhall has, after 6 years, decided to step down from the PCC and his post as treasurer. Many thanks to him for his service to the PCC. Finally, thanks are due to our team of flower arrangers, church cleaners, and graveyard maintainers who ensure St Swithin is such a lovely church to visit and worship in.

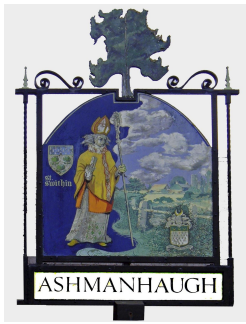
We had two very generous donations this year. One in memory of Jill Sharpe enabled us to purchase cushion seats for every pew in the church. The other involved the construction and installation of new enclosed noticeboards in the church entrance. These were kindly donated by Paul Rowan.

We also managed to secure a grant from the EDP Community Chest Initiative and this enabled us to purchase 6 soft chairs with arms for use at our Preston Rooms events.

Congregations at the major festivals were between 22 and 46, but at our regular services only 6 or 7 attended. This leads me to the issue of finance. In 2016/17 the annual expenses were £9807 and the income £9276 a deficit of £531. In line with Diocesan policy the benefice is moving towards attempting to meet the realistic costs of having an incumbent, thus the costs of running St Swithin and maintaining our services are increasing on an annual basis. I would like to record our heartfelt thanks to both those who actively engage in our fund raising, and the parishioners of this and nearby villages who give so generously at our events. We are dependent on the goodwill of the whole community and those who support us from outside the village, but it is likely that this year will see us continuing to run with an even larger deficit, which will be met from the reserves. Only some of this increase can be met by fundraising and quite honestly I do not believe that we can raise much more by running events. We will not run any coffee mornings in the coming year as they do not appear to be as popular as they once were and the work involved is quite onerous. As in 2016 we will be running the fete in conjunction with the Preston Rooms Committee and we will run our usual Autumn events. The other option to events is to increase giving, and since our congregations are so small this means looking to those who are willing to support the church even if they are not regular attenders. We are investigating setting up a Friends group to help expedite this. The reserves will be able to cover the deficit for approximately five years. Difficult times ahead.

6 Preston Rooms report - Steve Newstead.

Good progress has been made on the fabric of the building with three new heaters being installed. The electricians have also been tested and unfortunately failed, but the fuse board has been upgraded and an RCD installed. All the smaller windows, including the kitchen, have been replaced with double glazed units. The big windows will be replaced at some point in the future.

7 Cricket Club report.

Anne Wallace, General Secretary, sent her apologies. Harry Buxton said a few words on their behalf. They are undergoing due to changes last season. On the downside the 1st and 2nd teams were relegated and the 3rd team disbanded. However the Sunday team has been promoted and the Juniors did very well especially the under 9's and under 11's. The future of the cricket ground in Ashmanhaugh is of concern to those in the village. ABWCC are putting a package together to improve the Pavilion and the ground, including signage and a list of fixtures. There is a new Director of Youth cricket, Harry Buxton with new nets (30 attended last week) and an ECB sponsored programme. In Senior cricket there are some new players and there will be two teams based at Barton Turf and a Sunday team at Ashmanhaugh.

8 Light Railway report - John Pond.

Has seen an increase in members, now standing at 24 members, and a completely new engine joining the group this year, making 11 in total. This is a new experience as all engines have previously been secondhand. Thanked Hazel from the Preston Rooms for operating a fundraising book stall during open days. Planning permission for the clubroom extension was granted in January and building work has begun. Lots of information about the railway is available on the website. Open days in 2017 are: 7th May, 4th June, 2nd July, 6th August, 3rd September, 1st October from 2pm to 5pm.

9 Poor's Land report - Rachel Buxton

The Board now has a full complement of Trustees. They are Mrs Rachel Buxton (Chair), Ms Sarah Hewitt, Mr William Mulhall, Mr Neal Sharpe and Mr Terry Childerhouse who has now joined the Board. The Board has three regular meetings a year but will call extraordinary meetings if necessary.

The objective of the Trust is

- The relief of poverty
- To improve the quality of life for those residents who have need by reason of youth, age, ill-health, disability, financial hardship or other disadvantages.
- The advancement of education.
- The advancement of community development.
- Greater use of community buildings.

The annual return to the Charity Commission has been completed and is available on the website. Currently, the Trust has some £5,000 of uncommitted funds available for grants.

In the current financial year, the Trust is providing a grant to the village hall for heating improvements.
