

# MINUTES OF ASHMANHAUGH PARISH COUNCIL MEETING

## Held in the Preston Room on Wednesday 23<sup>rd</sup> February 2022 at 7.00pm.

The Chair opened the meeting and welcomed everyone.

- 1. ATTENDANCE: All Councillors were present.
- DECLARATIONS OF INTEREST AND REQUEST FOR DISPENSATIONS FOR THIS MEETING: Cllr. C Phillipo and Cllr. Laingchild declared an interest in Item 5.1 planning application PF/21/3471 as neighbours.
- 3. MINUTES OF PREVIOUS MEETING To confirm the accuracy of the minutes of the Parish Council meeting held on 11<sup>th</sup> January 2022.

The minutes of the meeting held on 11<sup>th</sup> January 2022 were proposed by Cllr. Russell and seconded by Cllr. Phillipo as a correct record without amendment – these were AGREED by all and were duly signed by the Chair.

### 4. PUBLIC SPEAKING

### 4.1. To receive questions from the public relating to local issues.

A representative from Wroxham Barns spoke regarding the submitted planning application and explained the reasons and plans for the proposal. Each member of the public, and Councillors, were given the opportunity to raise comments and ask questions of the applicant, all of which were responded to and actions taken so far to rectify were given.

The key issues raised were noise issues, concerns regarding increased volumes of traffic, flooding issues, light pollution, footpaths, and dog bins.

Wroxham Barns stated they would work with the Parish to try to resolve any arising issues.

#### 5. HIGHWAYS, PLANNING, LAND AND ASSET ISSUES 5.1. To consider any planning applications receive

To consider any planning applications received: PF/21/3471 - Land To South East Of, Wroxham Barns, Tunstead Road, Hoveton, Norwich, Norfolk, NR12 8QU - Change of use of land from agriculture to camping site with 25 no. serviced tent pitches and 5 no. 'Safari Tents' with verandas; marquee extension to existing toilet block to provide shower and toilet facilities Clir. Phillipo abstained from voting.

**Resolution**: It was voted (4 for and 1 against) to **SUPPORT** the application with the following comments:

- 1. Highways comments are addressed and resolved
- 2. Dark sky policy adhered to and reduction of existing light pollution
- 3. A sound Management plan regarding noise issues from the site is put in place due to serious concerns by residents

#### 5.2. To ratify planning application decisions received between meetings: PF/22/0155 - Brackenbank, School Road, Ashmanhaugh, Norwich, Norfolk, NR12 8YN -Change of use of land from agriculture to garden/amenity land associated with Brackenbank Resolution: No Objection – this was AGREED by all.
