#### 4.1. To receive a report from County and District Councillor

District/County Councillor Nigel Dixon spoke about Reinforced Autoclaved Aerated Concrete (RAAC) - only one school in Norfolk possibly affected and being assessed; buildings being transferred from NCC to Trusts; Nutrient Neutrality update; Low Traffic Neighbourhoods not being progressed in Norfolk; DC's Highways budget £10,000 can be applied for; local bin collection issues.

A member of the public raised the 'unofficial passing places' along Stone Lane and their condition and whether any improvements can be made. It was responded by Cllr. Dixon that these are within Hoveton Parish who are considering them.

A member of the public commented on farm contractors loading trailers too high and damaging trees.
